

Lake Kanasatka Watershed Association 2024 in Review

One year after the kickoff of the LKWA Capital Campaign, our association is in an incredibly strong position to meet our future with regard to water quality, stormwater mitigation projects, number of LakeSmart awardees, fundraising totals and actively engaged volunteers working throughout the watershed.

Initial discussions with the NH Department of Environmental Services (NH DES) in the spring of 2023 helped us better understand the scope, necessary steps and costs associated with addressing the deteriorating water quality of Lake Kanasatka.

To that end, LKWA hired FB Environmental Associates to help guide us towards best lake management practices as outlined in the LKWA Watershed-Based Management Plan and to quantify our water quality history, past and present, for the purposes of grant applications.

A Capital Campaign was launched in mid-November 2023, which successfully raised over \$400,000 in six months thanks to the generosity of our donors. LKWA applied for a Cyanobacteria Mitigation Fund grant from the State of NH in January 2024, as well as several additional state and federal grants. Numerous meetings and extensive and detailed paperwork followed throughout the winter and spring as LKWA met each requirement and deadline, successfully resulting in the approval of several grants benefitting LKWA for a total of \$857,283.

During the spring of 2024, an alum treatment was approved by New Hampshire Department of Environmental Services (NH DES) to address the "legacy" internal phosphorus, which was identified through water testing as a significant source of the cyanobacteria blooms our lake had been experiencing. The treatment took place in May, resulting in a return to crystal clear water for the summer of 2024.

LKWA has contracted with a highly regarded geomorphologist, a scientist who studies individual natural topographical features to understand the processes that shape landforms, to conduct a stream assessment in the coming months to ensure that stormwater runoff from the streams throughout the LKWA watershed are not adding unwanted nutrients into Lake Kanasatka. Data on flow and infiltration rate, turbidity, erosion, soil type, sedimentation and other indicators will be investigated and analyzed. Any necessary mitigations/restorations will follow.

A design and engineering project for several private roads around the lake is in the planning stage for 2025, with funding from a NH Watershed Assistance 319 grant and matching funds and in-kind services from LKWA. This project focus is to reduce stormwater flow into the lake from the area around the Burton Road and Foster Drive intersection. All owners of the properties impacted by these projects have been asked to grant written permission to LKWA to access their properties solely for the purposes of an initial evaluation. But the journey does not end here.

We need YOU to join LKWA and participate actively in our projects. One way is to join or renew your membership in LKWA at, https://kanasatka.org/join_or_renew_membership/

Another way is to become an active lake-friendly property owner, since an alum treatment does not guarantee a bloom-free lake in the future. The work continues with efforts focused on addressing sources of external phosphorus loading in the form of stormwater runoff entering the lake and failing septic systems. Please do your part by

- keeping a vegetated border along the shoreline to prevent leaves, dirt and other debris from entering the lake
- adhering to the NH Shoreland Water Quality Protection Act (SWQPA), which regulates activities that are located within 250 ft of the <u>reference line</u> of public waters (all NH lakes). Such activities include construction & necessary permitting, the cutting of trees and the use of fertilizers. See details here, https://www.des.nh.gov/protected-shoreland-fag#fag30936
- having your septic system inspected and repaired as necessary- LKWA will reimburse up to 50% of the cost of a residential inspection (up to a maximum of \$200). **see further requirements on our website at https://kanasatka.org/septic-system-inspection-assistance-program/
- creating a rain garden or installing water razors to catch the stormwater runoff and divert it away from the lake
- operating your boat in a manner that does not make big wakes that hit the shoreline and erode the soil.

Update on 319 Grant

In early 2024, Lake Kanasatka Watershed Association (LKWA) applied for a \$100,000 NH Department of Environmental Services (NHDES) grant, which requires \$67,000 in matching funds from LKWA, to address runoff/drainage issues at the intersection of Burton Road and Foster Drive. We have worked with NHDES throughout the year to complete the Grant process and are now anticipating final State approval in December. The LKWA Board has appointed Scott Wallace to be the 319 Grant Project Manager to address the many contractual and administrative steps required by the State.

The project focus is to reduce or eliminate stormwater runoff into the lake from the area around the Burton/Foster intersection. Improvements may include: regrading the existing road, establishing a grassy swale with ditches and check dams, water razor diverters, enlarged culverts, etc. All work will be reviewed and approved by the affected landowners and will be completed at no cost to them.

This fall, we have contacted all Burton Road and Foster Drive residents to let them know about the 319 Grant and provide an outlook of 2025 activities. We requested that affected property owners sign a Consent Agreement to allow LKWA, NHDES, and engineering contractors access to their properties for evaluation purposes.

We have also issued a Request for Qualifications (RFQ) document to solicit input from interested engineering firms who may wish to bid on the project work. Responses are due in early January and we will select a contractor later that

Let us all make a resolution this year to continue to be proactive in protecting and preserving Lake Kanasatka in 2025 for ourselves and for future generations. month. LKWA will then work with NHDES to prepare and execute a contract for the project work. We anticipate starting site evaluations and design review meetings with residents in late winter/early spring. Our goal is to complete the work in late summer/early fall 2025.

Some consider this to be when a boat can be navigated from one end of a lake or pond to the other, or when the lake is completely free of ice. Update on Sales and Transfers of Waterfront Properties with Individual Sewage Disposal Systems in the Protected Shoreland

"As of September 1, 2024, the law regarding the transfer of developed properties served by an individual sewage disposal system (ISDS) has changed. Previously, sellers of these properties were required to have a permitted ISDS designer prepare a waterfront site assessment.

Now buyers of these properties are required to have the system evaluated by a permitted septic system evaluator. In certain situations, a permitted ISDS designer may also be required to determine if the effluent disposal area (EDA) is not providing proper treatment because it is too close to the seasonal high-water table.

If an evaluator determines that the ISDS is showing signs of failure or if the designer determines that the EDA is in failure, buyers are required to replace the ISDS within 180 days of the property transfer." (Courtesy of NH Department of Environmental Services)

Water Quality- this team is out on the lake every other week throughout the boating season, checking water clarity, recording temperature and dissolved oxygen profiles from water surface to lake bottom, collecting water samples for UNH lab testing, and checking for signs of cyanobacteria and more. This team also accompanies UNH personnel out on the water when needed. This important position requires a boat at your disposal and regular availability throughout the summer months. White Pine Needle Disease (WPND)

You have probably noticed that NH's stately White Pines are in trouble. Eastern white pine, (Pinus strobus), "is one of the most economically valuable and ecologically important forest trees in the northeast." It is also a common landscape tree for many of us in this area of New Hampshire. In recent years, white pines in our region have shown rather dramatic symptoms of problematic decline, including: yellowing/browning needles, heavy and early needle shedding, thinning canopies, undersized shoots and needles, branch dieback and, in extreme cases, death of the tree.

There are a lot of factors- climate change, drought and/or wet springs and insect infestation. Please refer to the following articles for further information on symptoms and management protocols as well as photos showing white pines needle blight.

Lake Kanasatka Board Meeting Summary October 22, 2024 4:30 PM via Zoom

Kirk requested a motion to approve September minutes, Eileen Ehman made a motion to approve minutes, seconded by Janna Hoiberg. Kirk brought to a vote, all approved the motion. The board voted unanimously not to renew the Meredith Chamber of Commerce membership annual dues payment (\$100).

1.) Treasurer Report: Eileen Ehman presented the Treasurer's Report.

Wakondah is being sampled now by UNH (phosphorus and plankton samples) Wakondah has a cyanobacteria bloom active now, not a surface bloom.

- 3.) 319 Grant: Kirk Meloney: Application is complete and sent to DES last Tuesday 10/15. Scott Wallace sent the RFQ to Jeff Marcoux (DES) for review.
- 4.) Membership & Outreach: Peg Devine is working on our membership lists. Online payment system to be reviewed by Peg Devine and Ryan Lovlien to simplify the process of joining

Lake Kanasatka Board Meeting Summary September 24, 2024 4:30 PM via Zoom

The meeting of the LKWA Board of Directors was called to order at 4:30 pm by President Kirk Meloney. Directors present were Janna Hoiberg, Scott Apgar, Eileen Ehman, Chris Wallace, Lisa Hutchinson, Kevin Kelly, Scott Parker and Tim Baker.

- 1) Kirk requested a motion to approve August minutes, Janna Hoiberg made a motion to approve minutes, seconded by Lisa Hutchinson. Board unanimously approved the motion.
- 2) Treasurer Report: Eileen Ehman presented the Treasurers Report.

Tim Baker made a motion to approve September bill payments, seconded by Chris Wallace. Kirk Meloney brought to a vote, the board unanimously approved payment of the following September bills:

3) Streams:

On Sept 9 LKWA Board members (Kevin Kelly, Lisa Hutchinson, Tim Baker, Kirk Meloney) met with John Field, an expert on the environmental impact of Streams. A presentation was given to John Fields on our situation with respect to the streams flowing into Lake Kanasatka and he came back to us with a proposal for restoration of the streams.

This proposal would put us in a better future position to apply for grants to assist cleaning up our streams.

Tim made a motion to accept the proposal and engage with John Fields, Kevin Kelly seconded the motion.

The motion carried with 8 approvals and one Director, Eileen Ehmann, abstaining from the vote as she didn't have sufficient time to review the materials prior to the vote.

4) 319 Grant Update

Scott Wallace, LKWA Member in good standing, volunteered to serve as Project Manager for our 319 Grant application. The Board enthusiastically accepted his offer.

- 5) Communications: Chris Wallace presented that we have the newsletter planned for release in October, there is nothing else planned currently.
- 6) T-Shirts new T-Shirts are in, \$25 cost plus shipping (\$7 if required).
- 7) Boots On the Ground a partial list of work completed in the last couple of months:
 - a) Installed a new culvert on resident's property 8/10 and 8/20
 - b) Additional substantial improvements on Sandy Cove Road to install large dry well/infiltration pits, 8/19.
 - c) Spread over 15 yards of gravel on a resident's property to improve road down to lake,

pitching runoff into the woods. Subsequent work done to install water razors and reestablish existing culvert.
